The Chairman noted that this General Assembly meeting was being conducted in accordance with the General Assembly postal ballot *GAPB 1-2020*, September 21st 2020. The meeting was therefore correctly convened in terms of notice and documentation as set out in Article 5 of the PEFC Statutes; and that the quorum (as defined in Article 5.12) had been achieved.

Prior to the commencement of the formal business of the General Assembly, the President of the PEFC International Stakeholder Member, Building and Wood Worker's International (BWI), Per-Olaf Sjöö, made a keynote speech on the challenges of the pandemic; welcoming the social requirements, amongst others a living wage added by PEFC to its standards recently, and setting out some new opportunities for development and cooperation on social issues, seen from a work force' perspective.

REPORT ON RESULTS OF GENERAL ASSEMBLY POSTAL BALLOT VOTES HELD IN THE PERIOD BETWEEN SENDING OUT PAPERS (14TH OCTOBER 2020) FOR THE 25TH GENERAL ASSEMBLY (11th NOVEMBER 2020) AND 20TH OCTOBER 2021

GA Postal Ballot 1-2021 (19 June 2021)

MOTION: To endorse the Ukrainian National Voluntary Forest Certification System, subject to an in-country visit during the initial 18 months' period, including an evaluation on the successful implementation of the "Action plan to prevent the risk of illegal wood and corruption in forest sector of Ukraine"
