Revision of the LFCS / Technical Committee Postal Ballot
On the approval of the LFCS ST 1004 - Sustainable Forest Management – Criteria and indicators – 06.06.2025

In order to enable an easy and traceable voting procedure, it was decided that the final voting would take place via an online postal ballot. Of all 13 stakeholders invited to vote, 12 votes in favour were received and one stakeholder (FSHCL) did not vote at all (no opposition nor abstention), probably due to internal communication problems within the stakeholders own organisation. As the voting was closed for the date of the GA of PEFC Luxembourg on 11.06.2025, 12 out of 13 stakeholders were deemed sufficient and the standards were presented on the GA and in consequence recommended for approval to the GA of PEFC Luxembourg a.s.b.l.
